PREFACE

The Annual Reports of the Managing Committee of the American School of Classical Studies at Athens have been published as follows:

Reports 1 (1881-1882) -15 (1895-1896) were published by the Managing Committee of the School. (The first, second, and third annual reports were reprinted in 1886 and published in one pamphlet).

Reports 16 (1896-1897) -27 (1907-1908) were printed in the *American Journal of Archaeology*, 2nd series, Vols. I-XII; usually, but not always, as part of a supplement.

Reports 28 (1908-1909) -47 (1927-1928) were printed in the *Bulletins* of the Archaeological Institute of America, Vols. I-XIX (Vol. II contains no report).

In 1928 the Institute ceased to publish these *Bulletins* and for eleven years, 1928-1938, there were no published reports of the Managing Committee. The Executive Committee of the Managing Committee felt that it would be desirable to remedy this situation by publishing extracts from the Minutes of the Annual Meetings of the Managing Committee for this period. Such a publication was accordingly authorized at a meeting at Hartford, Connecticut, December 31, 1941.

Fortunately, the minutes of these annual meetings have been most carefully kept by the Secretaries, Professors Perry and Van Hook. They contain full summaries of the Chairman's Reports and complete reports of the Publication and Fellowship Committees. It has been thought wise to substitute the Thucydidean certainty of the Treasurer's Reports for the Delphic adumbrations of the Budgets.

The present publication covers Reports 48 (1928-1929) -58 (1938-1939), issued for convenience in three volumes.

Reports 59 (1939-1940) and 60 (1940-1941) are published by the Managing Committee of the School.

THE FIFTY-FIRST ANNUAL REPORT OF THE AMERICAN SCHOOL OF CLASSICAL STUDIES AT ATHENS, 1931-1932

The Annual Meeting of the Managing Committee was held May 28, 1932

The Meeting was called to order by the Chairman at 10:05 a. m.

(NOTE: On account of the absence of the Chairman in Greece the date of the meeting had been postponed from May 14, the statutory time, by vote of the Executive Committee.)

REPORT OF THE CHAIRMAN, Professor Edward Capps

The Chairman, after thanking the Committee for consenting to a postponement in order to enable him to be present at the meeting, spoke at length upon the several errands which called for his presence in Greece during the spring. He reported that the transition from the Directorship of Professor Carpenter to that of Professor Stillwell had been facilitated by a great deal of consultation and the participation of the next Director in the work of preparing the new Budget. The work of the School will go on without a break.

The business administration is in excellent condition and the plant has been inspected and all work done which seemed desirable by way of repairs and replacements. No important improvements will be needed for some time. There was general satisfaction among the staff and students with the administration of Loring Hall. Complete harmony seems to prevail and the two Annual Professors, Babbitt and Bassett express hearty commendation not only of the administration of the several departments of the School, but also for the high quality of the students of the current year.

The Chairman also reported at some length upon the new Museum at Corinth. It has been successfully completed and the work of installation began the second week of May. It will be followed by the preparation of the labels for exhibited objects—a work which will require expert assistants during at least the first half of next year. This undertaking is being planned as a part of the larger task of preparing and ultimately publishing a scientific catalogue of all the antiquities exhibited and stored in the Museum. Professor Carpenter has revised the *Guide to Corinth*, the first edition of which has been exhausted, and will have the new edition ready for publication during the current year.

The Chairman likewise reported that the Oakley House Annex has been finished and is now occupied. The building is of inexpensive but earthquake-proof construction and is a very attractive and comfortable dormitory. The reconstruction of

Oakley House, whose present condition is distinctly dangerous, will be taken up next and carried through under the direct supervision of Director Stillwell, who will remove the second story and provide the curtailed structure with a new roof.

Report was also made upon the excavation of the Agora, giving a résumé of what had been accomplished in the first two campaigns and the plans for the third campaign in the winter and spring of 1933; also, concerning the financial resources which have been provided for the next three-year period and the proposals which will be submitted to the Agora Commission for the budgetary arrangements for the coming year. The minor excavations which were carried on last year by Professor Broneer on the northern slope of the Acropolis, and by Dr. Thompson in the Pnyx, were likewise reported upon and attention was called to the desirability of continuing both excavations and of a provision in the Budget which would enable the School to finance a small campaign in each region.

He referred also to the progress of the negotiations with the Greek Government concerning the proposed small museum in Mytilene toward whose construction the Rockefeller Foundation had made a provisional grant of \$14,000. If the joint recommendation of the Archaeological Bureau of the Ministry of Education and the School should be found to be satisfactory to the Foundation, it is hoped that the work of construction may be taken up in the near future.

Finally, the Chairman touched upon the progress which has been made in connection with the subscription list of *Hesperia*, and estimated that by carrying out a consistent plan for bringing the journal to the attention of libraries and scholars in Europe and America the outlook was encouraging for a respectable subscription list at the end of the current year. In this connection, he outlined a plan for the issue in the autumn of a number of Volume I, which would be devoted to the work of the Agora, the plan being to issue each year at least one special number of the publication which should be devoted exclusively to the Agora.

The withdrawal of Ohio State University as a Supporting Institution of the School was reported.

The Secretary reported briefly that the Committee had lost by death the following members since the last Annual Meeting: Professors F. G. Allinson (June, 1931), C. F. Smith (August, 1931), H. M. Tyler (November, 1931), Miss L. S. King (January, 1932).

REPORT OF THE EXECUTIVE COMMITTEE

The Executive Committee reported as follows:

Actions taken since the Annual Meeting of May, 1931

1. On account of the absence of Professor S. E. Bassett, Chairman of the Committee on Fellowships, for the current academic year, Professor C. A. Robinson, Jr., was added to that Committee.

2. The publication of Professor Broneer's monograph on the Odeum at Corinth at a cost of \$1800 was authorized on the recommendation of Professor Chase, Chairman of the Committee on Publications (March 21, 1932).
3. The postponement of the Annual Meeting from May 14 to May 28 was authorized.

Actions taken May 27, 1932

It was voted to recommend to the Managing Committee the following action:

1. That the resignation of Miss Alice Walton of Wellesley from the Managing Committee be accepted.
2. That Professors Barbara McCarthy of Wellesley College, Sidney Deane of Smith College, Charles H. Morgan, II of Amherst College and Benjamin C. Clough of Brown University be elected to the Managing Committee.
3. That Professors Rhys Carpenter and Frank C. Babbitt be elected as members of the Executive Committee for the term of three years in place of Professors L. E. Lord and J. A. Scott, whose terms of office have expired.
4. That Professors G. H. Chase (as Chairman), D. M. Robinson and G. W. Elderkin be appointed as the Committee on Publications, with Professor H. N. Fowler, editor of the Corinth Publications, as an *ex officio* member.
5. That Professors S. E. Bassett (as Chairman), C. A. Robinson, Jr., and A. B. West (the last named taking the place of B. D. Meritt who serves as Visiting Professor for 1932-1933) be appointed as the Committee on Fellowships.
6. That Professors C. B. Gulick (as Chairman), H. L. Crosby, and Rhys Carpenter be appointed as the Committee on Personnel.
7. That Professor G. H. Chase be appointed to represent the School as Associate Editor of the Journal of the Institute (A.J.A.)
8. That Professor R. J. Deferrari of the Catholic University of America be appointed Annual Professor and Professor Thomas Means of Bowdoin College Visiting Professor at the School for 1933-1934.
9. That Professor Oscar Broneer be re-appointed as Assistant Professor of Archaeology at the School for a term of three years at the same salary (\$3000) as at present.
10. That, on the recommendation of Librarian Lowe of the Gennadeion Theodore H. Erck, of Wabash College and the University of Illinois, be appointed Assistant in the Gennadius Library, for a term of two years at a salary of \$1400 and \$1500 per annum and

That Richard P. Breadon be appointed Assistant in the same Library for a term of one year at a salary of \$1200. These recommendations were approved.

In this list the volumes which have appeared during the year are: Corinth, Volume IX, Greek Sculpture; Diez and Demos, Byzantine Mosaics; and Dinsmoor, Archons of Athens. Volumes VIII, 1 and VIII, 2, devoted to the Greek Inscriptions and the Latin Inscriptions of Corinth, have been printed and are ready for distribution, but no sales have yet been reported.

In submitting a report of sales at Athens, Professor Carpenter adds, "A sad detail; we transmit our income from sales to Mr. Curtis every July 1. This year the drachma lost half of its value during the spring, so that the dollar equivalent for these sales is disappointing. We are raising the drachma sales price here; but this has no retrospective effect upon sales already made." The Committee would again urge members of the Managing Committee to make sure that libraries with which they are connected purchase the publications of the School as they appear.

Further progress in the publication of the results of excavations at Corinth has been made during the year. Volume X, devoted to the Odeum, by Mr. Broneer, is completely printed in Vienna and ready for distribution. Volume VI, devoted to the Coins, by Professor Edwards, is being set up at the Oxford University Press and should appear before the end of the present year. Progress is reported on the volume devoted to vases by Mrs. Kosmopoulos.

The Committee also reports that the first volume of the journal of the School, called "Hesperia," has been printed and distributed, and it has met with very general approval. It has been arranged that a second number, devoted to the excavation of the Agora, will be prepared by Professor Shear and ready, it is hoped, for distribution in the fall. In the final negotiations, a general agreement was reached that the management of "Hesperia" should rest with the Director and officers of the School, that the Publication Committee would act in an advisory capacity, but would not assume charge of the new periodical. The Harvard University Press will act as a distributing agent for single numbers and has agreed to receive subscriptions, but it seems clear that responsibility must be centered in one place, and that it should be the School in Athens.

The Committee asks for one formal action, the approval of Professor Dinsmoor's monograph on "Bassae: The Temple of Apollo Epicurius near Phigalia," which is almost ready to be submitted. I hope the Managing Committee will ap-

prove this publication, subject to the approval of the expense by the Executive Committee. No estimate of this expense is as yet possible.

On motion, the publication of Professor Dinsmoor's study of the temple at Bassae, subject to authorization of the Executive Committee concerning the expense, was approved.

The Chairman of the Committee on Publications asked for the sentiment of the Managing Committee regarding the advisability of reducing the price of Publications, e.g., of the Erechtheum book from \$40 to \$20. After some discussion, although no formal motion was made, it appeared to be the sense of the Committee that such reductions might well be made at once.

Professor Chase further announced that hereafter a formal agreement with the authors of official School publications would be made concerning the publication of expense involved.

REPORT OF THE COMMITTEE ON FELLOWSHIPS

PROFESSOR B. D. MERITT, Acting Chairman

Interest in the Fellowships offered by the School continues to grow. During the past year thirty requests for information were received from prospective candidates. Of these thirty applicants for information, eighteen sent formal applications to the Committee for permission to take the examinations. Before the time set for the examinations, several candidates felt compelled to withdraw from the competition, but even so there were eight contestants for the Fellowship in the Language, Literature and History of Ancient Greece and six contestants for the Fellowships in Archaeology.

The Committee recommended the appointment of the following:

1. As Fellow of the School in Archaeology, *Miss Gladys Davidson*.
Miss Davidson was graduated from New York University in 1930 with honors in Classics, and since 1930 has been a graduate student at the Johns Hopkins University.
2. As a Fellow of the Institute in Archaeology, *Mr. Edward Fluck*.
Mr. Fluck was graduated from Muhlenburg College in 1930 as Valedictorian of his class, and since 1930 has been a graduate student at the Johns Hopkins University.
3. As Holder of the Fellowship in the Language, Literature, and History of Ancient Greece, *Rev. Basil C. Kolar*.
Mr. Kolar was graduated from the St. Procopius College in 1921. He studied at the University of Chicago during the Summer Quarters of 1923-4-5-6-7-8, and during the Spring Quarters of 1925 and 1928. During the present academic year he has been a graduate student at the Catholic University of America.

The Committee was pleased by the high standard maintained in the examinations this year, not only in the competition for the Archaeological Fellowships, but also in the competition for the Literary Fellowship. This is particularly gratifying, inasmuch as some concern has been expressed in the past over the preparation of the candidates presenting themselves in this field. Had there been two Fellowships available this year, recommendations for two awards would gladly have been made.

The Committee has felt itself seriously handicapped by the temporary absence of its Chairman, Professor Bassett. At the same time, members of the Managing Committee have given their cooperation to good effect in making known to their students the opportunity offered by the Fellowships. The Committee takes this opportunity to emphasize again the necessity for as wide a publicity as possible, and requests the help of every member of the Managing Committee, next year also, in making the competition a success. Particular thanks must be given to these scholars who gave generously of their time in preparing and reading the examination papers this year: Messrs. H. N. Couch, P. H. Davis, Edward Fitch, F. P. Johnson, H. L. Jones, G. E. Mylonas, Miss M. Z. Pease, Messrs. C. A. Robinson, Jr., A. C. Schlesinger, Edward Weist, and A. B. West.

REPORT OF THE DIRECTORS OF THE AUXILIARY FUND

Professor L. E. Lord, as Chairman of the Directors of the Auxiliary Fund, submitted a tentative report to be followed later by a final statement. The amount of the subscriptions for the current year was tentatively set at approximately \$3700.
